

PRIVACY POLICY

1. Personal Data of the User on the Web page

Pursuant article 5 of the Organic Law 15/1999, of 13 December, on the Protection of Personal Data (hereinafter, “**LOPD**”) and its Regulation, ADMINISTRACIÓN CONCURSAL of AIFOS ARQUITECTURA Y PROMOCIONES INMOBILIARIAS, S.A. (henceforth, “**ADMINISTRACIÓN CONCURSAL AIFOS**”), as a result of Auto 316/2014, of Juzgado de lo Mercantil nº1 of Málaga/1bis, which establishes the suspension of the insolvent society AIFOS ARQUITECTURA Y PROMOCIONES INMOBILIARIAS, S.A. (hereinafter, the “**INSOLVENT**”), informs the user (hereafter, the “**User**”) that the personal data which are provided through the Webpage www.administradorconcursalaifos.com (henceforth, the “**Webpage**”), as well as those data that ADMINISTRACIÓN CONCURSAL AIFOS accesses as a result of surfing through the Internet, due to requests or the use of services (hereafter, “**Personal Data**”), will be incorporated into a file under the responsibility of ADMINISTRACIÓN CONCURSAL AIFOS.

The purposes for the obtention of the Personal Data of the Users are (i) give compliance to the legal obligations established, which demand the creditors’ knowledge on the existence of the loans they have against ADMINISTRACIÓN CONCURSAL AIFOS, (ii) inform of the development of the bankruptcy procedure of ADMINISTRACIÓN CONCURSAL AIFOS, (iii) carry out the administrative, financial and tax issues necessary for the handling of loans and (iv) attend the queries of the User that may arise through an email in the Web page.

With the acceptance of the present Privacy Policy, the User expressly authorises ADMINISTRACIÓN CONCURSAL AIFOS to process the Personal Data which may be voluntarily facilitated through the Webpage, or which may have been obtained as a consequence of surfing, request or use of the services, for the purposes described above.

In any case, the User will be able to exercise the rights of access, rectification, cancellation and opposition for the processing of the referred Personal Data in front of the ADMINISTRACIÓN CONCURSAL of AIFOS ARQUITECTURA Y PROMOCIONES INMOBILIARIAS, S.A., through an email directed to consultas@administradorconcursalaifos.com or through the ordinary mail at Calle Pirandello, 16, 5ª planta – 29010 Málaga, indicating the reference to “**LOPD ADMINISTRACIÓN CONCURSAL AIFOS**” in the terms established on the LOPD and the Royal Decree 1720/2007, of 21 December, which approves the Regulation implementing Organic Law 15/1999, of 13 December, on the Protection of Personal Data (hereinafter, the “**RLOPD**”).

2. Security measures

Pursuant the obligations established by article 9 of the LOPD and RLOPD, ADMINISTRACIÓN CONCURSAL AIFOS informs you that they have implemented technical and organisation security measures necessary to guarantee the security of Personal Data and to avoid the alteration, loss, processing and/or unauthorised access, taking into account the state of technology, the nature of the stored data and the risks to which they may be exposed, regardless whether they come from a human action or from the physical and natural influence.
